

Outcomes Programme

For bids over £15,000 per year over 3 years.

Deadline 12.00 noon 1/10/2019.

Following the launch of the 2018-2023 VCS strategy, the Community Fund Commissioning Programme will be centred on the following **5 priority outcomes**:

- 1. People live long, healthy, happy and independent lives
- 2. Our children and young people thrive and reach their full potential
- 3. Access to homes and prevention of homelessness
- 4. Everyone feels safer in their street, neighbourhood and home.
- 5. Everybody has the opportunity to work and build their career

- Core costs must evidence how the funding of staff etc. will contribute to meeting the Outcomes
- Direct delivery of activities to meet Outcomes
- Purchase of equipment if it directly relates to project delivery and helps meet Outcomes

Does the bid involve collaboration with other VCS groups?

We encourage Organisations to work together to deliver projects in collaboration and avoid duplication of similar projects. Collaboration can take many forms and may range from strong communication and sign posting to formal collaboration agreements and joint staffing arrangements.

Is it tackling a particular need in a locality?

We are asking Organisations to use evidence in their tender application form that groups of people or communities are in need of a particular service or project in any area in the borough, or that the proposed service will address a particular need.

Does it focus on prevention, early identification and intervention?

Extensive research shows that intervening early with the appropriate support and help can have a positive impact and bring about lasting change for people. Therefore we encourage projects to have a focus on prevention, early identification and intervention.

Does it support one or more of the priority Outcomes?

With limited resources the Council has to be selective with what it can fund. Organisations are asked to evidence how their proposed project links to and supports at least one of the priority Outcomes for residents.

Is it evidence based?

Organisations may have services which have been informed by evidence or tested in some way to show impact and benefit over time. This could help articulate what success looks like and demonstrates an effective use of money.

Is it innovative?

The Community Fund is not about funding the same Organisations or projects purely because we always have. We encourage innovation from new or existing Organisations and projects.
